CENTURY HORSE RACING CLUB MEMBERSHIP AGREEMENT

December 1, 2023

This agreement is made effective as of _____ (date) by and between Century Horse Racing Club (CHRC or the “Club”) and _____ (the

“Member”) pursuant to the laws of the province of ALBERTA. The dominant purpose of this agreement is the enjoyment of horses and horse racing and is not designed to be an investment opportunity.

Under the direction of Century Mile Racetrack and Casino and/or Century Downs Racetrack and Casino (the “Management”), the welfare of the horses leased, owned or otherwise cared for at the discretion of CHRC is paramount at all times.

Article I CLUB NAME AND REGISTRATION

Section 1.01 The name shall be Century Horse Racing Club. ‘Century Horse Racing Club’ shall appear on any declarations and not any one person’s name. CHRC is a registered entity with Horse Racing Alberta (HRA). It has its own dedicated horsemen’s purse accounts with the Horsemen’s Benevolent & Protective Association of Alberta, and the Alberta Standardbred Horse Association (“Horsemen’s Associations”) for club transactions.

Section 1.02 The CHRC trustees shall be Century Casinos Management and their delegates. These are the only persons responsible for liaising with HRA and the Horsemen’s Associations. Only the trustees shall liaise with HRA or the Horsemen’s Associations regarding the Club.

Section 1.03 The trustees shall be responsible for all associated paperwork with HRA and the Horsemen’s Associations. No member of the Club should engage with HRA, the Horsemen’s Associations, racetracks, or media on the Clubs behalf or on racing related matters without prior written consent from one of the trustees.

Article II MEMBERSHIP

Section 2.01 Membership to the club is available to all persons able to meet the required upfront membership share fees and is in good standing with Century Casinos.

Section 2.02 A membership share is effective until November 30, 2024 (the ‘Membership Period’).

Section 2.03 Membership shares are limited to one (1) share per member. These shares are non-transferrable.

Section 2.04 Membership shares are limited to one name holder per membership. Memberships cannot be shared between multiple individuals or groups.

Section 2.05 Membership shareholders must be 18 years of age or older.

Section 2.06 Members are reminded that membership with the Club allows them to have an interest in activities pursuant to the Club and does not amount to racehorse ownership. Membership is an opportunity to enjoy the experience and entertainment

associated with racehorse ownership. It is not an investment opportunity and cannot be utilised for any commercial purpose.

- Section 2.07 Membership includes, where possible, but is not limited to; current racehorses in training, as well as all race information and club activities communicated by email, social media and the CHRC website. Membership also grants members access to CHRC member-only merchandise.
- Section 2.08 Members will receive the applicable HRA Horsemen's Discount in participating Food and Beverage establishments at Century Mile and Century Downs. Conditions may apply.
- Section 2.09 Members are invited to participate in CHRC specific activities throughout the membership period which may include, but is not limited to; barn tours, watch parties, and club gatherings. Details of dates and times will be provided to the members via email or phone. Members will be asked to confirm attendance prior to the activity unless otherwise stated. Priority of attendance will go to club members first. Should space allow, then additional family members may be permitted to attend. The Management reserves the right to limit access and availability of club activities at their discretion.
- Section 2.10 In accordance with HRA licensing, licensed Club members will have access to the backstretch and barn areas at both CDR and CMR. Backstretch visits are asked to be coordinated through Club Management.
- Section 2.11 All Club horse(s) are leased and/or owned by the Club and if sold or claimed, the Management may endeavour to find a replacement(s) as quickly as possible. Suitable horses will be sourced by Management and Club trainers. All monies earned for claimed/sold horses are exempt from Section 3.07.
- Section 2.12 The Management reserves the right to terminate or suspend membership, without reimbursement, with immediate effect at any time if any conduct by the member, which in the Management's opinion, is damaging to the character or interests of the Club or offensive to other members, racetrack staff, or the general public.

Article III FINANCE AND CLUB TREASURER

- Section 3.01 The Management shall act as the club treasurer and shall be responsible for all financial matters and decisions made on behalf of the Club.
- Section 3.02 The Membership Fee shall be \$325 per membership period.
- Section 3.03 Each share purchased in the Club is non-refundable. Members are not permitted to sell shares.
- Section 3.04 Membership is not subject to any additional requests for payment in relation to the care, training and racing of the horses, no matter what costs the Club may incur
- Section 3.05 All training, care and racing related expenses are the responsibility of the Club. Membership fees will be allocated at discretion of the Management to cover the following costs including, but not limited to:

- a) Horse registration fees
- b) Banking fees
- c) Training fees
- d) Blacksmith, veterinary, and dentist fees
- e) Jockey or drivers fees
- f) Transportation costs
- g) Insurance fees
- h) Any other costs the Management feels are instrumental to the welfare of the Club horses and the benefit of Club members

Section 3.06 If the Management is of the opinion at any time that there are insufficient members to fund the Club's activities at a level consistent with its objectives then the Management reserves the right to halt horse racing activities of the Club, and reserves the right to refund to all those who have purchased a share in the CHRC without interest as per the remainder of the membership period. Should this occur mid-season, the refund shall be prorated.

Section 3.07 Purse money won by the horse(s) during the membership period is distributed amongst the members equally at the end of the period. There is no guarantee of any level or amount of purse money, given that this is dependent on the horse(s) performance and training costs. The sum distributed to members is determined by the relative net total remaining at the end of period. Additional deductions may include but are not limited to, supplement fees, training expenses, and other expenses at the sole discretion of the Management.

Section 3.08 The Management have carefully planned for the Club to have a successful future, but should the Club be dissolved or disbanded for any reason, the Club will pay any fees owed to HRA, the Horsemen's Associations, and/or the trainer as a priority.

Section 3.09 There will be no reimbursement of the cost of the membership share should a Member wish to terminate their membership within the agreement period.

Article IV EQUINE MANAGEMENT

Section 4.01 All decisions made regarding Club horses will be made by Management and their respective teams, in the best interest of the horse.

Section 4.02 Club Trainers will be selected by Management. Trainers may vary from year to year. All Trainers must be in good standing with Century Casinos and Horse Racing Alberta.

Section 4.03 Club Trainers will be responsible for the day-to-day care and conditioning of the respective horses and will communicate regularly with Management. Any medical issues that may arise with a Club horse will be dealt with by the Management, Trainer, and their respective veterinary teams, in the best interest of the horse.

Section 4.04 Horses will be entered into races deemed suitable for their current conditions and fitness levels.

Section 4.05 Should a Club horse be entered into a Claiming race, it is eligible to be purchased from the Club. In the case where a Club horse is claimed, it will no longer be part of

the Club stable as of the conclusion of the race. Management will source a replacement at their discretion. Any earnings from a claim/sale will be excluded from Section 3.07.

Article V RISK ACCEPTED BY MEMBERS

Section 5.01 In view of the unpredictable nature of owning and racing horses, save the terms and conditions addressed expressly in this agreement, no guarantees or warranties whatsoever are made by the Club or the Management.

Section 5.02 The Member acknowledges and accepts that participation in the Club is for the purpose of entertainment and enjoyment of the horse racing, and not for investment purposes.

Section 5.03 The Management reserves the right to amend these Terms and Conditions at anytime without prior notice to the Member.
