







Colorado Real GDP (\$BN)⁽²⁾







Poland Gaming Market Revenue⁽¹⁾ (EUR MM)



Net Operating Revenue: CAGR 2015 – 2017






Per Operating Segment

Net Operating Revenue








Net Operating Revenue per Quarter 2015 - 2017
