


International Casino and Entertainment Company





Century Casino & Hotel Central City

The economy and consumer sentiment in the greater Denver metro area very strong and we see consumers growing more confident and showing a greater willingness to spend.

Century Casino & Hotel Cripple Creek

Effective marketing programs, double-digit increase in hotel revenue. Focus on growing VIP player development.



Canada (Alberta) 2015 vs. 2014

Century Casino & Hotel Edmonton

Increase on table games, decrease on slots. Asian Baccarat players seem unaffected by economy (oil), slot players feel it. Substantial renovation and increase of gaming floor, VIP rooms, bar and restaurant areas.

Century Casino Calgary

Growth of the drop on tables, but low hold resulted in revenue decrease. Focus on growing table games volume and players' club loyalty program.

Century Downs Racetrack and Casino

Profitable from day one. Strong operating margins. Only race track in greater Calgary area, located on QE2 highway adjacent to major regional shopping mall.

Poland (Eastern Europe) 2015 vs. 2014

Net Operating Revenue22%Adj. EBITDA118%

Nine Casinos in Warsaw (2), Krakow, Lodz, Wroclaw, Poznan, Katowice, Sosnowiec and Plock

Strong operational growth, tables up, slots up, F&B up. More and higher-quality slots, player loyalty program installed. All non-casino slot arcades closed.

Unfavorable court ruling on March 9: Casinos Poland Ltd. responsible for tax on tips to casino dealers. Written ruling with more details expected soon. Higher staff cost going forward, potential one-time charge.






Net Operating Revenue by Segment / Region






Adjusted EBITDA by Segment / Region






Net Operating Revenue per Quarter






Adj. EBITDA per Quarter

With a healthy balance sheet and our growing and well-diversified line-up of mid-size casino resorts, the Company is well positioned to create even more value in 2016.

- Continued operational improvement at existing properties
- Off-track betting parlor expansion in Southern Alberta
- Northlands Park Edmonton announced end of horse racing 2016 could present opportunity for Century
- Two new TUI Cruises ship-casino openings in 2016 and 2017 (2,500 passengers each)
- New Thomson Cruises ship-casino opening in 2016 (2,100 passengers)
- Additional projects under consideration
